Since the Department of Digital Economics and Management Innovation (International Program) of International College has set a date for a qualifying examination for the doctoral students in Digital Economics and Management Innovation (International Program) for the First Round for the First Semester of the Academic Year 2025, the schedule for a written examination and an interview are on Friday, August 8, 2025.

To conduct for aforementioned qualifying examination proceed smoothly under Article 28 of Maejo University regulations on Graduate Studies in 2019 the University has set the date for the examination as follows:

1. Applying on Monday, July 14, 2025, until Wednesday, July 16, 2025, at the Graduate Studies Department.

2. Announcement of a list of eligible candidates for the examination by Monday, July 21, 2025.

3. The last day of the waiver of the examination by Wednesday, July 23, 2025.

4. Date, time, and details of the examination

4.1 The applicants are required to submit concept papers to propose as a research guideline for their dissertation in the form prescribed by the program to the Examination Committee at last 15 days before the qualifying exam date.

4.2 Students take the qualifying examination by presenting their research proposals as guidelines for their dissertation based on the questions of the Examination Committee.

4.3 The Examination Committee will assess the readiness and competence of the students and decide whether or not they have sufficient knowledge to study and complete their doctorate dissertation under the criteria set by the program.


